DESCRIPTION

Bostik Green Remover has been formulated to quickly and easily remove green growth from external surfaces. It is suitable for use on patios, paths, walls, roofs, stone and PVC. It is not suitable for use on metal surfaces. For exterior use only.

As the tablets are concentrated, the packs are small, lightweight and easy to transport. As the packs are smaller than traditional cleaners, less plastic is used in the packaging which lowers CO₂ emissions when transporting Bostik Green Remover.

COVERAGE

- Approx. 4m² per litre of water
(depending on substrate texture, porosity & application technique)

APPLICATION

IMPORTANT: Before using Bostik Green Remover, refer to the relevant Health & Safety Data Sheet, available at www.bostik.com/uk.

PREPARATION

- Bostik Green Remover is for outdoor use only.
- Ensure the surface is free from loose materials and soil. Remove weeds and any thick surface growths with a wire brush or stiff broom before application.
- During wet weather, Bostik Green Remover may be washed away before it has had time to act. Do not apply in wet weather, or when rain is expected.
- Apply between March and November to dry, external surfaces (when there has been no rain for several days).
- Dilute and test on a small, concealed area before proceeding to clean the whole area. The test area should be examined after 24 hours to safeguard against any unwanted changes in appearance.

APPLICATION

- Fill either a watering can, or a pressure sprayer with ambient water and add tablets as follows:
Light green staining: 1 tablet per litre of water
Mid green staining: 2 tablets per litre of water
Heavy green staining: 3 tablets per litre of water
- Allow tablets to dissolve for a minimum of 5 minutes and mix thoroughly.
- Animals and children must be kept away from the treatment area during application and until the area is completely dry and free from any residual product.
- Apply the diluted Bostik Green Remover generously onto surfaces. Do not rinse and allow to dry.
- The treatment takes between 1 to 5 days to start working, depending on the level of green growth and weather conditions. The green staining loosens and can be brushed or washed away.
- Where growth is severe, two applications may be necessary. Allow 24 hours between applications.
- Wash off any product splashed onto plants or lawns with clean water.
- Do not apply to metal surfaces, use near foodstuffs or breathe vapours.

CLEANING

- Clean tools and equipment with water immediately after use. Thoroughly rinse watering can after use.

STORAGE

- Store and transport securely in an upright position. Ensure the lid is fully closed. Store for up to 3 years from date of manufacture in original, unopened packaging in cool, dry conditions within the temperature range +5°C to +30°C and out of direct sunlight. Protect from frost.

PRECAUTIONS IN USE

This cleaner is for external use only.

Do not mix or use with any other chemicals. Protect lawns and plants during application and when rinsing away Bostik Green Remover. Do not contaminate ground, waterbodies, watercourses or ponds with product. Prevent surface run-off from entering drains. Bostik Green Remover is not intended for use as a lawn treatment.
